RSMeans Guide Schemes & Contract Guide Settings


Do you use multiple RSMeans guide settings? Do you manage multiple contracts in Project Estimator? Would it be awesome to effortlessly ensure your entire team is using the correct guide settings for all of your contracts? Would it be sweet to move from project to project and contract to contract without worrying about using the wrong guide settings?

Implementing a couple of the newest features in your Project Estimator tool bag allows you to accomplish all of this!

Scheme Panel

We think the new **Scheme** panel capability will really help you manage your RSMeans guides settings. Previously, you could only save one RSMeans setting. Now you can save as many as you would like and easily select the one you need to use.

Your **Scheme** settings are either **Contract**, **Other**, or **Favorite**. We will see how to setup the **Contract** setting in a minute. **Favorite** represents the setting preset you have denoted as such, and **Other** captures everything else. You can use the **Choose** button to open the **Guide Settings Presets window** where you can manage the presets through your **right-click** menu options. The **Update Guide Settings** window allows you to determine the settings you would like for each preset.





RSMeans Guide Schemes & Contract Guide Settings (CON'T)

Update Contract Window

Now let's see how to set up your **Contract** setting. You will notice a new option on the **General** tab of your **Update Contract** window. If you turn on the **Set Contract Guide Settings** option, the **Contract Guide Settings** tab appears. Clicking on this tab allows you to set up the guide settings for your contract, or you can use the **Look up global guide setting** button to open the **Guide Settings Presets** window we just saw. You can even lock your settings to avoid accidental changes.

Your Project Estimator System Administrator can set this up for your team, and then everyone will reap the benefits!



One final cool way to use these presets is when you choose to re-price estimates during the import or paste process!

Q & A Corner

Q: I'm looking at the Line Items tab of the Updating Estimate window. If I add up the totals of all of all of my line items, why do I get a different number than the estimate total at the bottom right of the window?

A: Good eye! The estimated total at the bottom of the window INCLUDES totalling components. The total of each line item does NOT include totalling components.

Q: I just changed the unit of measure (UM) of my line item on the Updating Line Item Details window. Why didn't it change on the Line Items tab of the Updating Estimate window?

A: The Line Item panel on the Line Items tab is strictly linked to the pricing guide from where the line item came. So even if you use a unit of measure conversion and change the UM of a line item, the UM on the Line Item Details panel will remain unchanged. It displays the Extended UM from the Updating Line Item details window. The good news is that the totals are properly calculated!

Q: My estimate is supposed to include an RSMeans City Cost Index, but the RSMeans Cost Data panel on the Line Items tab of the Updating Estimate window states that there is "No City Cost Index in use for this item." Should there be?

A: RSMeans City Cost Indexes (CCI's) can be applied two ways. The first is directly into the line item itself. In this case the RSMeans Cost Data panel will represent the CCI information being used by the highlighted line item. The second and probably most common - way is to apply the CCI with totalling components. In this case, we don't want the CCI applied directly to the line item; so we don't double-dip the CCI. We simply need to click on the General tab of the Updating Estimate window to verify which CCI the totalling components are applying.
