Construction Cost Estimating

Public Sector and Unit Price Books

Definition of a detailed cost estimate: "A forecast of construction cost, prepared on the basis of a detailed analysis of materials and labor for all items of work." — 13th edition of the Architect's Handbook of Professional Practice

A detailed, unit cost, line item construction cost estimate involves a review and understanding of the scope of work of the associated project, including all possible factors and risks. Materials, labor, and equipment, as well as associated costs are provided in the highest level of granularity. Anticipated productivity is also a key element. The latter can be affected by multiple variables, such as labor composition and availability, weather, site access, materials availability, etc.

Owners – Detailed, unit price, line time estimates are required by public agencies for most IDIQ construction projects. If the project exceeds a specified dollar threshold, an independent owner estimate must also be created (also called an independent government estimate – IGE). Line item estimates are also used to create and validate construction budgets.

Contractors – Detailed, unit price, line item estimates are used to bid jobs and also done by general contractors and construction managers to validate bids from sub-contractors.

Required Skills – Field experience at construction sites is extremely important, as it is the only way to gain a true appreciation of risk factors and other variables that can impact a construction project. The ability to review and interpret construction drawings, work with cost estimating formulas and technologies, and the ability to communicate information to disparate disciplines and audiences are also vital.

Process Tasks – Processes associated with creating a line item construction cost estimate include the following:

- Definition of services to be provided
- Estimate preparation
- Validation of contents and assumptions
- Estimate reconciliation (if multiple estimates are required for a project)
- Documenting and presenting the estimate
- Defining the scope of services requires several considerations, such as:
 - o Identifying inclusions and exclusions
 - Defining the basis to be used for pricing (construction cost databases and/or unit price books – UPB, unit price guides, subcontractor quotes)
 - Presentation of line items as bare costs or inclusive of overhead and profit
 - Classification system to be used, i.e. CSI MasterFormat, Uniformat II, WBS, etc.
 - Format of the estimate (summary level, detailed level, price vs. non pre-priced items, associated formulas, source of each line item).

Collaboration among construction project participants and/or stakeholder is critical to assuring a proper definition of the scope of services, and thus mandatory if the estimate is to reflect the expectations of the owners, design, contractor, etc. Achieving the best possible outcome for the estimate and the overall construction project, is dependent upon the processes involved in gathering accurate information in a timely manner. Employing the actions and philosophies associated with continuous improvement and LEAN best management practices adds to the overall success as well.

Wright Patterson AFB



We are excited to celebrate and spotlight our great clients at Wright-Patterson AFB, Ohio! We earned their business in March of 2001, and still continue to support their Engineering, Operations, Planning and SABER teams.

Wright-Patterson Air Force Base is one of the U.S. Air Force's largest and most important installations. It is the birthplace, home and future of aerospace. Huffman Prairie Flying Field, located adjacent to the base's main runway, is the site of the world's first operational airfield and where the Wright-Brothers, in their own words, "really learned to fly."

Wright-Patterson AFB was established in 1948 as a merger of Patterson and Wright Fields. In 1995, negotiations to end the Bosnian War were held at the base, resulting in the Dayton Agreement that ended the war. Wright-Patt's highly specialized workforce of approximately 27,000 military, civilian and contract employees provide vital support to ensure Air Force and joint warfighters have modernized systems needed to fly, fight and win.

By virtually any measure, Wright-Patt is the most diverse and organizationally complex base in the U.S. Air Force. This is where America's Air Force aircraft of tomorrow are conceived, developed, and acquired. Missions for base units vary from acquisition and logistics management, to research and development, advanced education, heavy airlift flight operations, intelligence, and a vast array of other activities.

On any given day, several hundred Wright-Patterson Air personnel are typically deployed or readying for deployment in support of Operation Enduring Freedom, global exercises and humanitarian operations. Security Forces, physicians, nurses, and other medical technicians, intelligence analysts, contracting and logistics professionals are just some of the people Wright-Patt deploys. This is also the headquarters for Air Force Materiel Command, which directs a global logistics system and how the nation's aeronautical weapon systems are conceived, tested, acquired and modernized. Gen. Janet Wolfenbarger, the AFMC commander, is the highest ranking official at this installation.

The Air Force Life Cycle Management Center is one of five centers reporting to the Air Force Materiel Command. Led by a 3-star general officer, AFLCMC is charged with life cycle management of Air Force weapon systems from their inception to retirement. Portfolios include: aircraft engines, armaments, strategic systems, Information Technology systems and networks. It also includes Command, Control, Communications, Intelligence, Surveillance and Reconnaissance systems, and various specialized or supporting systems such as simulators and personal equipment. AFLCMC also executes the Air Force's foreign military sales mission.

Air Force Research Laboratory headquarters, along with four of its nine technical directorates charged with leading the discovery of new warfighting capabilities is located here. AFRL is involved in such varied projects as: advanced adaptive, highly-efficient engines, hypersonic propulsion, renewable alternative biofuels, cyber defense, penetrating weapons for deeply buried hard targets, directed energy and lightening the load and enhancing capabilities of Special Forces and individual battlefield Airmen.

Reserve Airmen from the 445th Airlift Wing regularly fly supplies, equipment and provide aeromedical evacuation for joint warfighters with the modern C-17 Globemaster III airlifter. National Air & Space Intelligence Center intelligence analysis on foreign aerospace capabilities is briefed daily to the nation's highest military and civilian leadership.

The Air Force Institute of Technology is the Air Force's premier institute of higher learning. AFIT supports national defense by providing graduate, post-graduate, and professional continuing education and research programs for Air Force, sister service, and foreign officers and civilians in pertinent scientific and technical disciplines. AFIT both conducts resident graduate education at Wright-Patt and also manages education at civilian universities, research centers, hospitals, and industrial organizations across the U.S.

The National Museum of the United States Air Force provides the general public with an awe-inspiring glimpse of the service's rich history and incredible capabilities. It is the world's largest military air and space museum.

The Enterprise Sourcing Group provides Air Force units based in the continental U.S. with cross-functional installation strategic sourcing and acquisition solutions. Strategic sourcing utilizes centrally awarded contracts for decentralized task orders execution to reduce federal government supplies and services costs.

Col. John Devillier command's the 88th Air Base Wing, host unit at Wright-Patt. He is responsible for operating, maintaining and defending the base and providing trained expeditionary Airmen for deployment. More than 5,000 Airmen, civilian and contractor employees operate the airfield, maintain all infrastructure and provide security, communications, engineering, medical, legal, personnel, contracting, finance, transportation, air traffic control, weather forecasting, public affairs, recreation and chaplain services.

Wright-Patterson Medical Center, part of the 88th Air Base Wing, is a major regional military medical treatment facility and one of the largest Air Force teaching hospitals. 4Clicks Technical Support: Tips & How To

I use Pro edition. I need to make changes to my estimate's line items and track those changes. Is that possible?

Users with the **Pro** edition of the software can use the software's **Revised Estimate** feature when they need to make changes to an estimate and track changes to them. This process involves making a copy of your original estimate, then changing the copy to use one of these two **estimate level** statuses: RFPn or MODn. The steps below will give you a brief overview of the steps involved. Contact technical support if you need further guidance.

- 1. Copy your Original Estimate (One Estimate Only): (Ctrl+Y to clone)
 - A. On the **Estimates** tab, highlight the estimate and use **Ctrl+Y** to start the clone process. (Do not tag)
 - B. Use the window **Set Properties for Newly Imported Estimates** to set the properties of the copy. There are many properties. Here are some tips:
 - 'Automatically Reprice...': Leave this check box blank.
 - **Estimate Description**: Adjust the name of the estimate.
 - Status: Set it to RFPn or MODn.
 - Totaling Components: Choose Use Totaling Components from the Clipboard.
 - Fields to Clear: Make sure these check boxes are blank.
 - Click **OK** on the 'Set Properties...' window to officially make the copy.
- 2. Open the New Estimate (the Copy) and Make Changes:
 - A. After the copy is made, open the new estimate. The **Line Items** tab will now allow you to view the line items with the columns **Estimated**, **Negotiated** and **Variance**. (Use the radio button labeled "###" to activate that view.)
 - Use the radio button labeled "\$\$\$" to activate the UM\Negotiated\Total view.
 - B. You can now start making quantity changes to your line items.
 - Quantity changes will show in the **Negotiated** column and the amount of change will display in the **Variance** column.
 - If there is a line item that you do NOT need, change the quantity to zero. (Do not delete the item or it cannot be tracked.)
 - Tip: Don't forget to make any relevant notes regarding the changes (inside the properties of the line items).
- 3. Run your Report:
 - A. When you are ready to run a report, open the **Estimate Report Options** window, to run a standard estimate report. However, you will want to choose the report called **Revised Estimate**. This report will display the columns for **Estimated**, **Negotiated** and **Variance**.
 - B. Revised Estimate is the only report that supports the use of RFPn and MODn changes for Pro users.

NOTE:

• This feature is not available in the **Basic** edition. **Premier** users would use the **Tech Eval** feature instead.
